## Coronavirus (COVID-19)

The government is removing remaining domestic restrictions in England. There are still steps you can take to reduce the risk of catching and spreading COVID-19:

- Get vaccinated
- Let fresh air in if meeting indoors, or meet outside
- Consider wearing a face covering in crowded, enclosed spaces
- <u>Get tested</u> if you have COVID-19 symptoms, and stay at home if positive

### The Government's plan for 'Living with Covid-19'

#### From 21 February

- staff and students in most education and childcare settings no longer need to undertake twice weekly asymptomatic testing
- staff and students of secondary age and above in SEND settings, alternative provision settings, and SEND units within mainstream settings or equivalent in further education colleges are advised to continue twice-weekly testing

#### From 24 February:

- people with Covid are not legally required to self-isolate
- however, guidance recommends that those who test positive stay at home and avoid contact with others for at least five full days
- self-isolation support payments of £500 for those on low incomes have stopped
- routine contact tracing has ended people in contact with someone with Covid will no longer be advised to self-isolate or take daily tests
- workers are not required to tell their employer if they need to self-isolate

#### From 1 April:

- PCR and lateral flow Covid tests will no longer be free for most people
- Covid passports will no longer be recommended, except for international travel
- employers will no longer have to consider Covid as a separate risk when working out how to keep employees safe

- As of 21 February 2022, you do not need to tell Ofsted if there is a confirmed case of COVID-19 at your nursery, childminder business or other day care.


#### You should:

Actions for early years and childcare providers during the COVID-19 pandemic



# When an individual develops COVID-19 symptoms or has a positive test

If you have any of the main symptoms of COVID-19 or a positive test result, the public health advice is to **stay at home and avoid contact with other people**.

Children and young people with COVID-19 should not attend their education setting while they are infectious.

#### VACCINES

Try to stay at home if you are unwell.




#### HAND WASHING


Wash your hands regularly to limit the spread of Covid-19.

#### **Bolton 2030** Active, Connected and Prosperous 12-15 years COVID-19 vaccination schools offer

Bolton NHS Foundation Trust responsible for delivering second phase of the COVID-19 vaccination programme to children aged 12-15 years in education settings:

- Operating through Bolton FT Schools Immunisation Team and subcontracted arrangements with local GP providers.
- The programme commenced 17th January and will run to 31st March.
- Offer includes 1st and 2nd doses\*
- Consent forms will be sent to school either as paper or electronic format depending on school preference. However, all consent forms need to be returned signed in paper format.

\*Criteria for children to have 2nd dose:

- Minimum of 12 weeks since first vaccine, unless they have a condition that means they are at higher risk of becoming seriously ill with Covid or live with someone at higher risk.
- Not tested positive for covid-19 in last 12 weeks

- The community offer at the walk-in centres will continue alongside the school offer and is coordinated by Bolton Clinical Commissioning Group (CCG)


#### **Bolton 2030** Active, Connected and Prosperous **5-11 years COVID-19 vaccination offer**

- MHRA (regulatory body medicines) approved vaccine safe for all 5-11yr olds Dec 2021
- As of January 31st children aged 5-11 years who are at higher risk from COVID-19 infection or those living with people who are immunosuppressed are already eligible for vaccination (low dose Pfizer, 2 doses, 8 weeks apart)
- Eligible children will have been identified and invited by their GP or hospital clinician to receive their vaccination at their GP practice or specialist clinic.
- Joint Committee for Vaccination and Immunisation (JCVI) have now recommended that the vaccination programme should be extended to ALL children aged 5-11 years.
- The programme roll-out will be 'non urgent' and based on parental choice
- The offer will be community based (rather than within educational settings) and will include pharmacies, GP practices and local vaccination sites.
- In Bolton CEV 5-11 circa 1160 Of which circa 100 have taken the vaccine

### **Bolton 2030** *Dealing with symptomatic pupils*

- Q. What advice should settings give to parents of children with covid symptoms testing prior to attending school via LFD or PCR / stay at home for 5 days? Can settings insist on this?
- Q. Will the guidance be for children to isolate even though this is no longer a legal requirement?
- Q. Should parents let us know if they test positive and have to isolate (even though this is not mandatory)? – min 5 days before they can start testing to come out of their self-imposed isolation

Children and young people with COVID-19 should not attend their education setting while they are infectious. They should take an LFD test from 5 days after their symptoms started (or the day their test was taken if they did not have symptoms) followed by another one the next day. If both these tests results are negative, they should return to their educational setting if they normally attend one, as long as they feel well enough to do so and do not have a temperature.




### Questions in advance Dealing with symptomatic pupils

**Q. Do we still send warn and inform letter to parents/staff for any positive cases in setting?** *No, warn and inform letters are no longer required. Please contact the Public Health team for advice on managing positive cases.* 

### Q. Testing from 01/04 if symptomatic – is this a PCR test? Settings will be sent testing kits – will these be PCR kits or LFD?

LFD. Consider encouraging staff and students to access test kits from their local pharmacy, collection from testing hub (Bolton Arena, or town centre), or by ordering online for home delivery <u>www.bolton.gov.uk/staycovidsafe</u>

From 1<sup>st</sup> April, education settings may be advised distribute tests on a temporary basis as an outbreak response measure if agreed with their Director of Public Health or Heath Protection Team, in line with the contingency framework.



## Questions in advance Reporting cases in setting

Q. Clarification on the reporting of positive cases – is the online form still in place and does it still need to be used, or just the phone line?

Q. What are we reporting on? If people no longer get free tests, will anyone actually test positive? Is it only positive test results we now report on or do we report suspected cases (symptomatic cases) as well? Will this data be accurate?

Please continue to report cases in the usual way. This helps us to monitor the local situation and respond quickly to clusters and outbreaks.

Universal free testing (PCR and LFD) continue to be available until 31<sup>st</sup> March. We are expecting further guidance on managing cases after this date.



### Q. Can we go back to using hand dryers instead of paper towels?

- Advice around not using dryers was removed a while ago.
- If the local assessment is that using towels is detrimental for housekeeping / hygiene and cost, settings are fine to switch them back on as long as they keep the area well ventilated (if possible).
